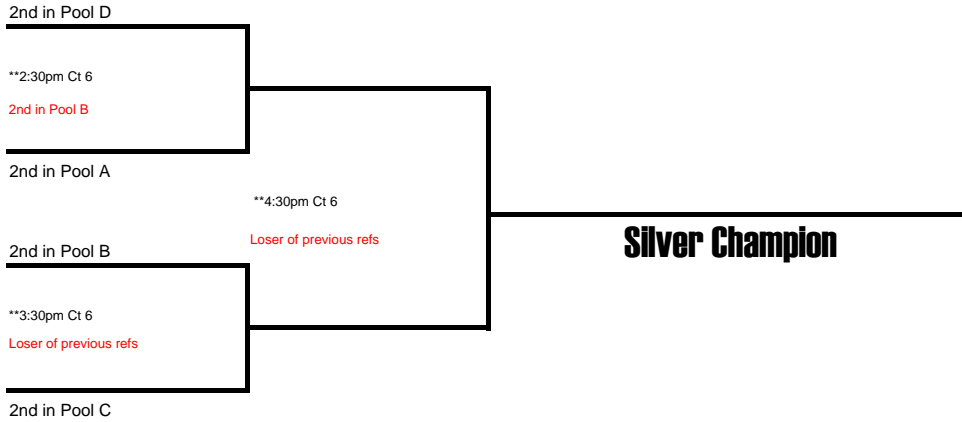

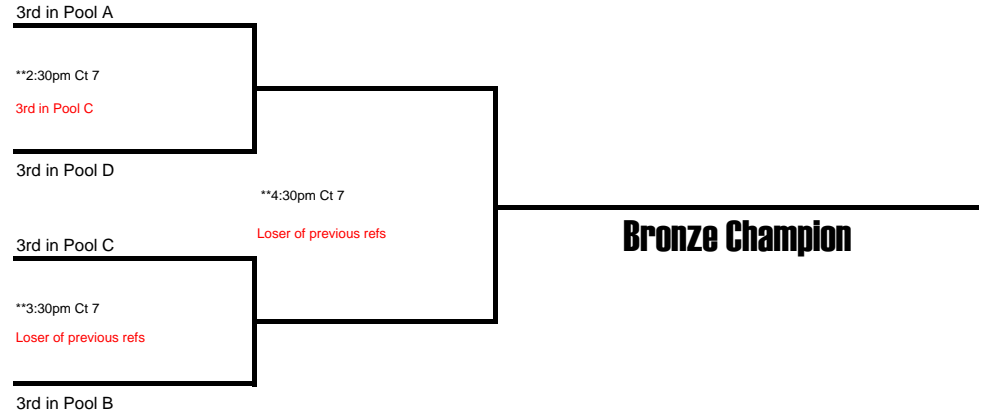
Silver Bracket

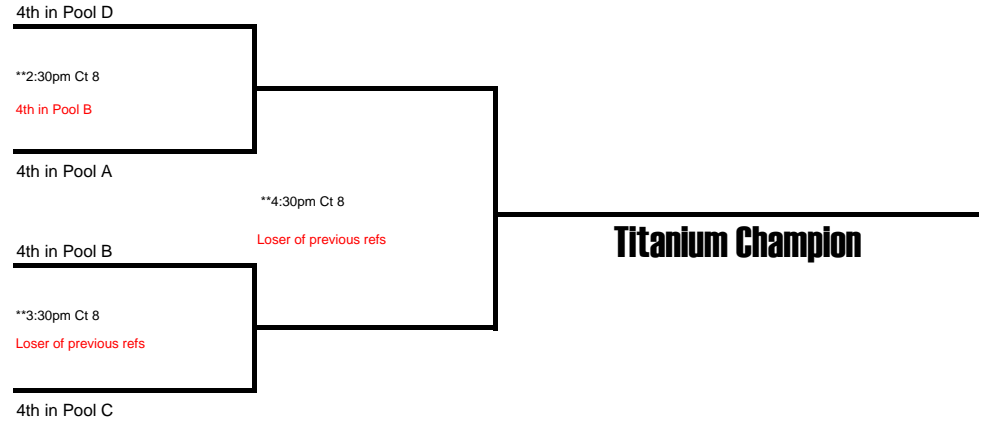
Bronze Bracket
