Tournament Rules:

USA Volleyball rules will be utilized. There will be a tournament directors table set up in the facility.

NO CARRY-INS ARE ALLOWED IN THE FACILITY. Concessions will be available.

The Dodgeland High School is a gum-free environment.

We ask that spectators and especially players do not bring any chairs into the facility.

No food, or beverages (other than water) will be allowed on the playing surfaces or scorable areas.

Teams may be fined up to 10 points in their next match if these rules are not followed.

Teams must have turned in their WEBPOINT roster at the tournament desk.

Facility Rules:

Please bring your own first aid supplies. Limited first aid will be available, ice will also be available.

Neither the Dodgeland High School nor Wisconsin PoWer are responsible for lost or stolen items.

Before leaving your bench area, please clean-up after yourself. Waste receptacles will be available.

There is a \$4 admission charge for this tournament for non-rostered spectators.

Facility Seating:

There are some chairs provided YOU MAY bring your own folding chairs into the facility.

Warm-Ups:

Team warm-ups will consist of 2-4-4 for the first two rounds and 3-3 starting with the 3rd match.

2 minutes shared, 4 for the serving team, and 4 for the receiving team, then 3 for the serving team and 3 for the receiving team.

Format:

Match play will be 2 out of 3, 1st two games to 25 pts, if necessary 3rd game to 15 pts for 4-team and 5-team pools. 3-team pools will be played 3 sets to 25 as indicated on the schedule. Win by 2, no cap on any set. All teams are guaranteed a minimum of 8 sets to 25 points.
