USA Volleyball rules will be utilized. There will be a tournament directors table set up in the facility. NO CARRY-INS ARE ALLOWED IN THE FACILITY. Concessions will be available.

No food, or beverages (other than water) will be allowed on the playing surfaces or scoretable areas.

Teams may be fined up to 10 points in their next match if these rules are not followed.

Teams must have turned in their SIGNUPTOPLAY roster and USAV numbers for their team.

Facility Rules:

Please bring your own first aid supplies. Limited first aid will be available, ice will also be available.

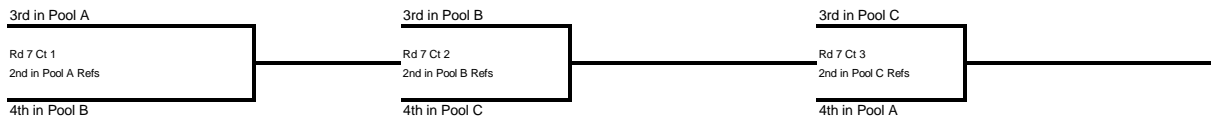
Top 2 teams of each pool advance to gold bracket.

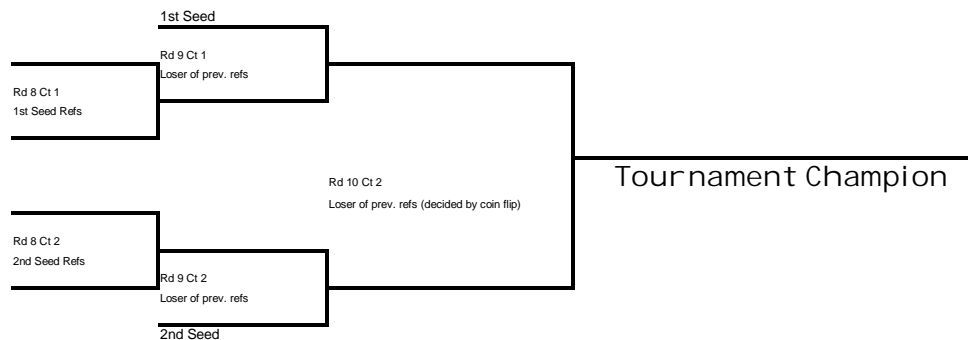
Crossover Matches
