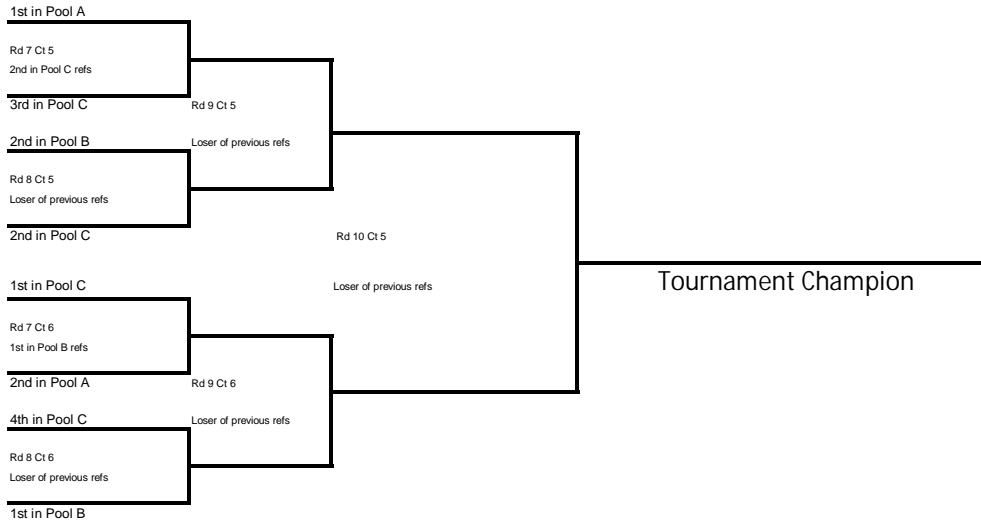

Championship Bracket

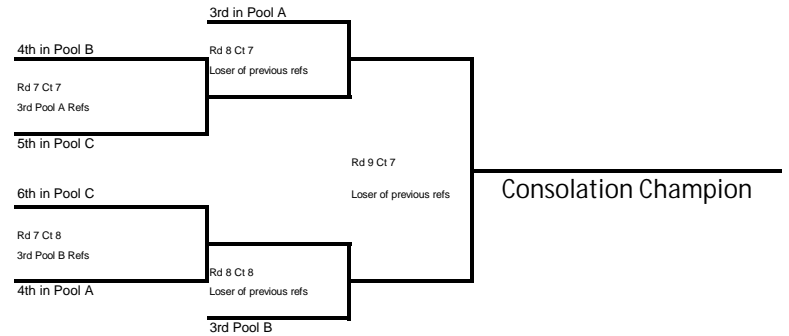
