Warm-ups will be 2-4-4

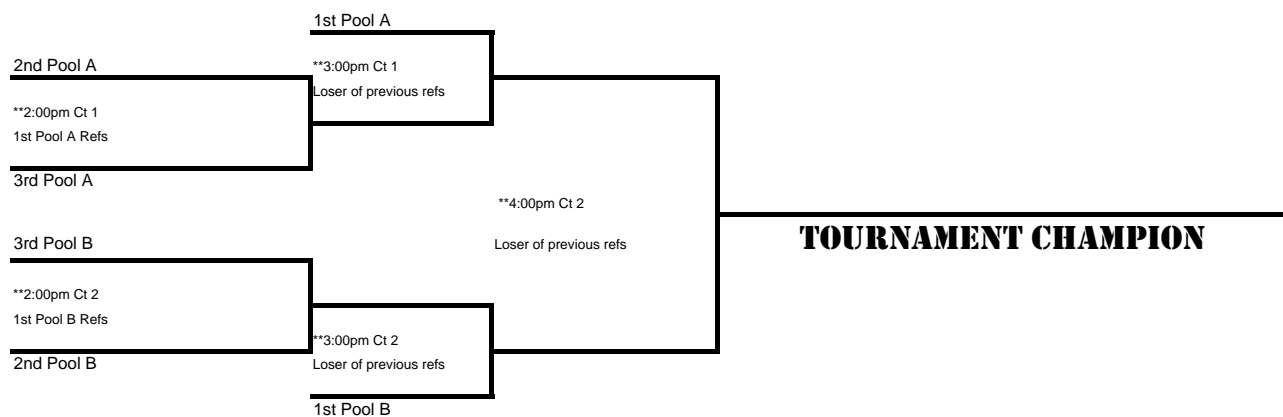
Play will begin at 8:00 AM
